



TEACHINGS OF ENDOMETRIOSIS

Terms Of Service

IMPORTANT: READ CAREFULLY BEFORE ACCESSING OR USING TEACHINGS OF ENDOMETRIOSIS PROPRIETARY SYSTEM INCLUDING ANY AUDIO AND/OR VISUAL PRESENTATIONS AND PROGRAMS ASSOCIATED WITH TEACHINGS OF ENDOMETRIOSIS. BY ACCESSING OR USING THE PROGRAM, YOU ACKNOWLEDGE THAT:

YOU HAVE READ THIS AGREEMENT,
YOU UNDERSTAND IT, AND
THAT YOU ACCEPT AND AGREE TO BE BOUND BY ITS TERMS.

This Agreement ("Agreement") is a legal contract between Body I Desire located at 4/A Hatvani Road, 5100 Jászberény, Hungary ("Body I Desire"), and the Student

WHEREAS, Body I Desire is engaged in this business of fitness training and personal development services; and WHEREAS, YOU desire to engage Body I Desire to provide fitness training and personal development services to YOU in the form of Live Online Fitness Group Classes, Live Online Private and Group Support Sessions, and Audio and Visual Presentations; NOW, THEREFORE, the Parties agree as follows:

SECTION 1: Membership and Program Fees

1.1. Program: Under the terms of this Agreement, Body I Desire agrees to provide fitness training and personal development services to YOU in the form of Live Online Fitness Group Classes, Live Online Private and Group Support Sessions, and Audio and Visual Presentations ("Program") in exchange for a Program Fee. Progression between Programs will occur automatically, and Program Fees will be determined according to paragraph 1.2. below. Your access to such Program is made conditional on payment of such Program Fee.

The Program is an online course which includes:

- Access to the Teachings of Endometriosis training modules for 1 year
- 24 x 1-hour live group fitness training classes for a maximum of 24 weeks or 48-hour online access to class recordings for pre-booked missed classes within the 24 weeks
- 1 x weekly 2-hour live group support sessions for 1 year
- Access to the live group support session recordings for 1 year
- 3 x 1-hour live private support sessions

1.1.2. Term: The Term of this Agreement will commence upon YOUR acceptance of this Agreement and payment of the applicable Program Fee.

1.1.3. Termination: Body I Desire may terminate this Agreement at any time in its discretion upon notice to YOU. Paragraph 3.1. below shall survive termination of this Agreement, binding YOU to Confidentiality in perpetuity.

1.2. Program Fee: By accepting the terms of this Agreement, YOU agree and understand that you are committing to pay the full program fee upfront before access to the course or you have agreed to a payment plan of which you will continue to pay until full program fee is paid off within 8 weeks of initial payment and accepting these terms.

1.3. Promotional Material: By accepting the terms of this Agreement and affirmatively seeking the benefits of membership in the Program offered by Body I Desire, YOU affirmatively agree and acknowledge that Body I Desire may at any time reproduce and/or disseminate any testimonial(s) describing or otherwise referencing, either directly or indirectly, YOUR experience participating in such Program, including any specific results experienced by YOU over the course of such participation. YOU agree and acknowledge that this includes any written statements you may publish to social media accounts and online forums as well as any statements and/or images captured or otherwise recorded over the course of attendance at any event(s) related to such Program.

1.4 Weekly Group Support Sessions: The weekly group support sessions shall be recorded and shared to existing and future Teachings of Endometriosis students. All private material shall be kept confidential should the material ever be published outside of the Teachings of Endometriosis Program.

SECTION 2: Warranties

2.1. Success not Guaranteed: By accepting the terms of this Agreement, YOU agree and understand that Body I Desire provides a Program related to training only and guarantees no specific results. YOU take full responsibility for YOUR own success.

2.2. Health Warnings: You and you alone are responsible for your choice to participate in the Program and for your own health and well-being at all times prior to, during and after your participation in the Program. Body I Desire will assume from your participation in the Program and from your declaration at the end of this document that you have a full understanding of the following health warnings.

2.2.1. The experience of the Program is unique to each individual. In general, it is normal for some people to experience unwanted or unfamiliar emotions from time to time, such as feeling confronted, fear, anger, sadness, upset, regret, irritation, and impatience. For most participants, exploring thoughts and feelings that they have not fully explored before is a useful and positive learning experience. For some participants exploring life's issues honestly may evoke uncomfortable and unpleasant feelings. If you are unwilling to encounter any of these powerful experiences in yourself or in others, or if you have any concern about your ability to deal with such experiences, Body I Desire strongly recommends that you do not participate in the Program.

2.2.2. If you

- have any unresolved history of drug abuse
- are or have in the past year considered suicide, self-harm or harm to another
- are currently in therapy and your therapist sees a health reason why you should not participate in the Program
- are uncertain about your physical, mental or emotional ability to participate in the Program

Body I Desire strongly recommends that you do not participate in the program.

2.2.3. The Program is not to be used as a substitute for medical treatments. Body I Desire advises you that the Program Leaders are not medical professionals.

2.3. Limited Liability: In no event will Body I Desire be liable to YOU or any party related to you for any damages, including damages for loss of business profits or other pecuniary loss, whether under a theory of contract, warranty, tort (including negligence) products liability or otherwise, even if Body I Desire has been advised of the possibility of such damages. Limitations herein described shall be applied to the greatest extent enforceable under applicable law.

2.4 Refund Policy: No refunds will be issued policy.

SECTION 3: Confidentiality

3.1. Confidentiality: Only authorized users, who have duly attained access to any Programs offered by Body I Desire by personally agreeing to the terms of this Agreement are permitted to use and participate in the Program. Except as expressly authorized by this Agreement, YOU shall not provide or make available any Documentation, Video, Audio, or any login member credentials to any third party, or use the Documentation, Video, Audio, or any login member credentials to teach any third party, or otherwise disclose or discuss information revealed in any portion of the Program for any purpose other than exercising rights expressly granted to you by this Agreement.

3.2. Nothing in this Agreement is intended to limit you from sharing your experience of the Program with anyone. This Agreement is intended to promote and respect the confidentiality of all of the participants in the Program (including their comments and actions in the Program).

3.3. Intellectual Property: YOU acknowledge that any Audio and/or Visual Presentations, Documentation, and other elements of the Program are the sole Intellectual Property of Body I Desire under Hungarian copyright, trademark and other intellectual property laws and international treaties. YOU further acknowledge and agree that, as between YOU and Body I Desire, Body I Desire and its third party licensors own and shall continue to own all right, title, and interest in and to the Audio and/or Visual Presentations, Documentation, and other elements of the System, including associated intellectual property rights under copyright, trade secret, patent, or trademark laws. Except for the limited, revocable license expressly granted to you herein, this Agreement does not grant you any ownership or other right or interest in or to the Audio and/or Visual Presentations, Documentation, and other elements of the Program, or any other intellectual property rights of Body I Desire whether by implication, estoppel, or otherwise. Any and all trademarks or service marks that Body I Desire uses in connection with services rendered by Body I Desire are marks owned by Body I Desire. This Agreement does not grant you any right, license, or interest in such marks, and you shall not assert any right, license, or interest in such marks or any words or designs that are confusingly similar to such marks.

SECTION 4: Miscellaneous

4.1. Non-transferability: The rights and obligations under this Agreement are personal to YOU. YOU may not assign or transfer any rights or obligations under this Agreement.

4.2. Indemnification: YOU will, at your own expense, defend, indemnify, and hold Body I Desire, its agents, and employees harmless from any and all claims, actions, liabilities, injuries, damages, losses, grants, costs, and expenses, including attorney fees, arising out of or in connection with any use of the Program of this Agreement.

4.3. Integration: This Agreement, along with any additional terms or policies incorporated herein by reference, represents the entire Agreement between YOU and Body I Desire concerning the Program, and this Agreement supersedes and replaces any prior proposal, representation, or understanding YOU may have had with Body I Desire relating to the Program, whether oral or written.

4.4. Amendment: Body I Desire reserves the right, in its sole discretion, to amend this Agreement from time to time by emailing you an updated version of the Agreement.

4.5. Governing law: This Agreement shall be governed by and interpreted in all respects in accordance with the laws of Hungary.

BY PURCHASING, YOU ACKNOWLEDGE THAT YOU UNDERSTAND AND AGREE TO ALL OF THE AFOREMENTIONED TERMS, INCLUDING THOSE RELATED TO PROGRAM FEES, AUTOMATIC MONTHLY BILLING, STRICT REFUND POLICY, AND CONFIDENTIALITY.
